As implemented last year we are continuing our Best Branch in SIR and in each Area Annual Award program that will be presented at the Annual Meeting on Wednesday, August 19 at the Chardonnay Golf Course in Napa. In addition, we are also beginning a new program, the Most Improved Branch. We encourage all Branches to compete for either one of the two awards.

If you are applying for the Best Branch award, complete and submit the Best 2020 Branch Recognition Qualification Form '**A1**' along with the Best 2020 Branch Self-Assessment Form '**A2**'. The deadline for submission to your Area Governor is **May 15**, using data from **January 1 to December 31**, 2019.

If you are applying for the Most Improved Branch award, complete and submit the Most Improved 2020 Branch Recognition Qualification Form '**B1**' along with the Most Improved 2020 Branch Self-Assessment Forms '**B2**' (two pages one for 2018 and one for 2019) **covering the period January 1 to December 31**. The deadline for submission to your Area Governor is **May 15**.

NOTE: Download the Award Program Documents as noted below. Then you and your BEC should decide whether the Best Branch or the Most Improved Branch program gives your Branch the best chance of winning that award and submit the appropriate documents.

In addition, your cover letter should highlight your Branch's significant accomplishments in 2019. The quality and thoughtfulness of the cover letter is an important consideration to the judges

Here's the process:

1. Branches submit the Qualification Form along with the documents specified to their Area Governor by May 15
2. Area Governors make a recommendation for Best Area Branch to their Regional Director by June 10
3. Area winning Qualification Forms are submitted by Regional Directors to the Presidential Best Branch Task Force by June 20
4. Presidential Task Force makes a decision on the Best Branch in SIR and a first and second runner up which is announced at the August 19 Annual Meeting
5. Feedback to non-winners provided by Area Governors after the Annual Meeting

The Area Branch winner *in each category* will receive an Area Governor's Branch Citation plaque and the Best Branch and Most Improved Branch in Sir will each receive a Dwight B. Sale perpetual trophy along with a \$300 award to recognize their significant accomplishments. We have eliminated the cash awards for the first and second runners up to pay for the Most Improved perpetual trophy.

All Branches that submit the Qualification Form and associated documents will be considered and the size of your Branch, the nature of its recruiting area and its bank balance are not deciding factors.
