

## List of SIR Qualified Travel Agencies

December 3, 2014

The agencies on this List of SIR Qualified Travel Agencies have submitted documentation to the SIR State Travel Committee and State Insurance Committee which has been reviewed and determined to show compliance with the travel agency requirements contained in Rule 380 as of the date shown above.

Branches may enter into a contract for travel activities and events with any agency on this list. If the agency is identified by **ATP** (Air Transportation Prohibited) it is because the agency does not have a current appointment to **ARC** (Airline Reporting Corporation) or **IATAN** (International Airlines Travel Agency Network) and may not be used for any travel event that uses transportation by aircraft during any segment of the event.

If the insurance of an agency expires 30 days prior to or during the travel event, the Branch Travel Chairman (BTC) must check the SIR website to ascertain if the insurance has been updated on the list of agencies, or contact the State Insurance Committee to ascertain the status of the insurance. Confirmation that the insurance was reinstated or renewed must be provided by the BTC to the Branch Secretary by an updated copy of the Qualified List or a signed and dated note as to how this was ascertained for filing with Form 53.

If the insurance of an agency in not renewed or is cancelled prior to the contracted travel event, the BTC shall immediately notify the State Insurance and Travel Committees of this fact. The State Insurance or Travel Committee shall then provide the BTC a recommendation on the status of the event.
